

## Calix Limited – Corporate governance statement

This corporate governance statement has been prepared in accordance with Corporate Governance Principals and Recommendations (4<sup>th</sup> Edition), ASX Corporate Governance Council and was current as at 29 August 2019, the date as of its approval by the Board of Directors of Calix Limited. All policy and charter documents have been reviewed and approved during the period. The Company's ASX Appendix 4G has been lodged with the ASX and is also on the Company's website.

Consequently, Calix does not propose to conduct specific checks prior to nominating an existing Director for re-election by Shareholders. However, Calix will continue to include in its notices of meeting a brief biography and other material information in relation to each Director who stands for re-election. The biography will set out (amongst other things) the relevant qualifications and professional experience of the nominated Director for consideration by Shareholders. Calix will conduct background checks of candidates for new Director positions prior to their appointment or nomination for election by Shareholders, including checks as to good character, experience, education, qualifications, criminal history and bankruptcy.

As at 30 June 2019, Calix had 42 employees with a mix of 15% female and 85% male which represented a 50% increase in female representation over the prior year. 1 member of the executive management team is female. The Board has commenced a process of recruiting an additional non-executive director with increasing board diversity being a key consideration in assessing qualified candidates within the next 12 months.
